### SUSPENSION DE LA COTATION DES TITRES DE LA SOCIETE « UADH »

Cette décision intervient à la suite de manquements graves constatés, notamment :

- l'absence d'informations fiables concernant les responsables de la société, ainsi que l'absence d'interlocuteurs, empêchant toute interaction avec les structures du marché financier ;
- l'absence de communication d'éléments probants attestant de l'existence d'une activité réelle.

Cette mesure conservatoire vise à garantir l'intégrité et la transparence du marché, ainsi qu'à assurer la protection des investisseurs.

La reprise de la cotation reste tributaire de la régularisation par la société « UADH » des manquements évoqués ci-dessus.
