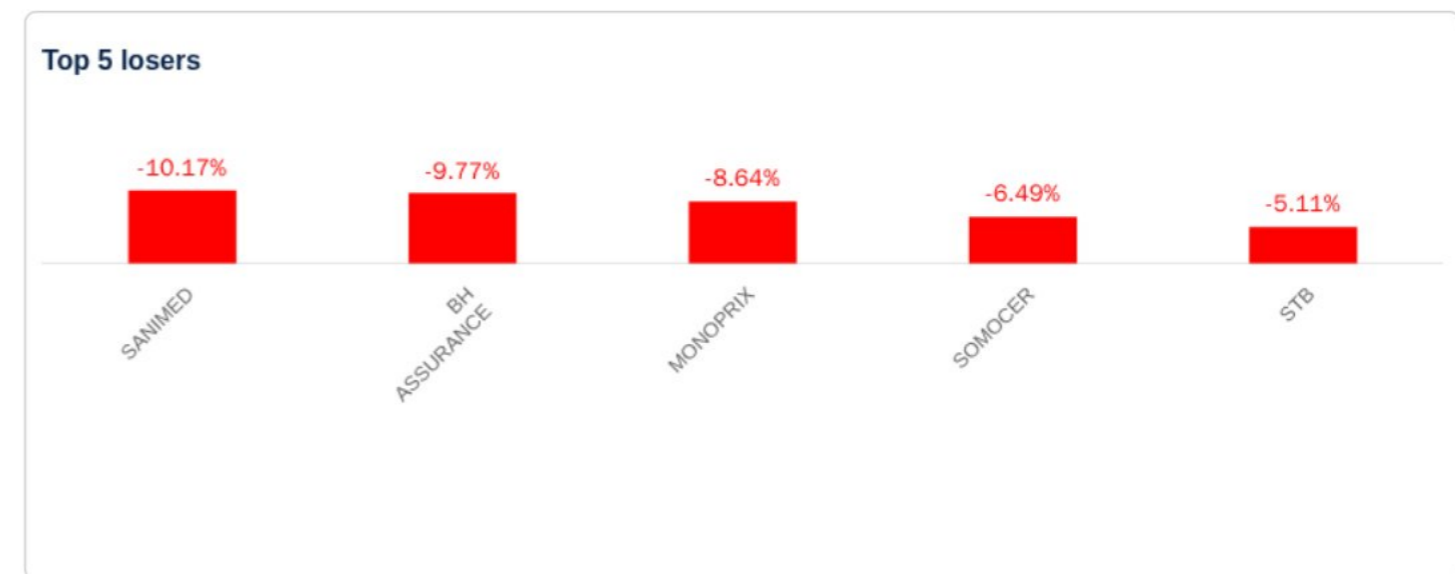

Volume breakdown between Central Order Book and Block Market



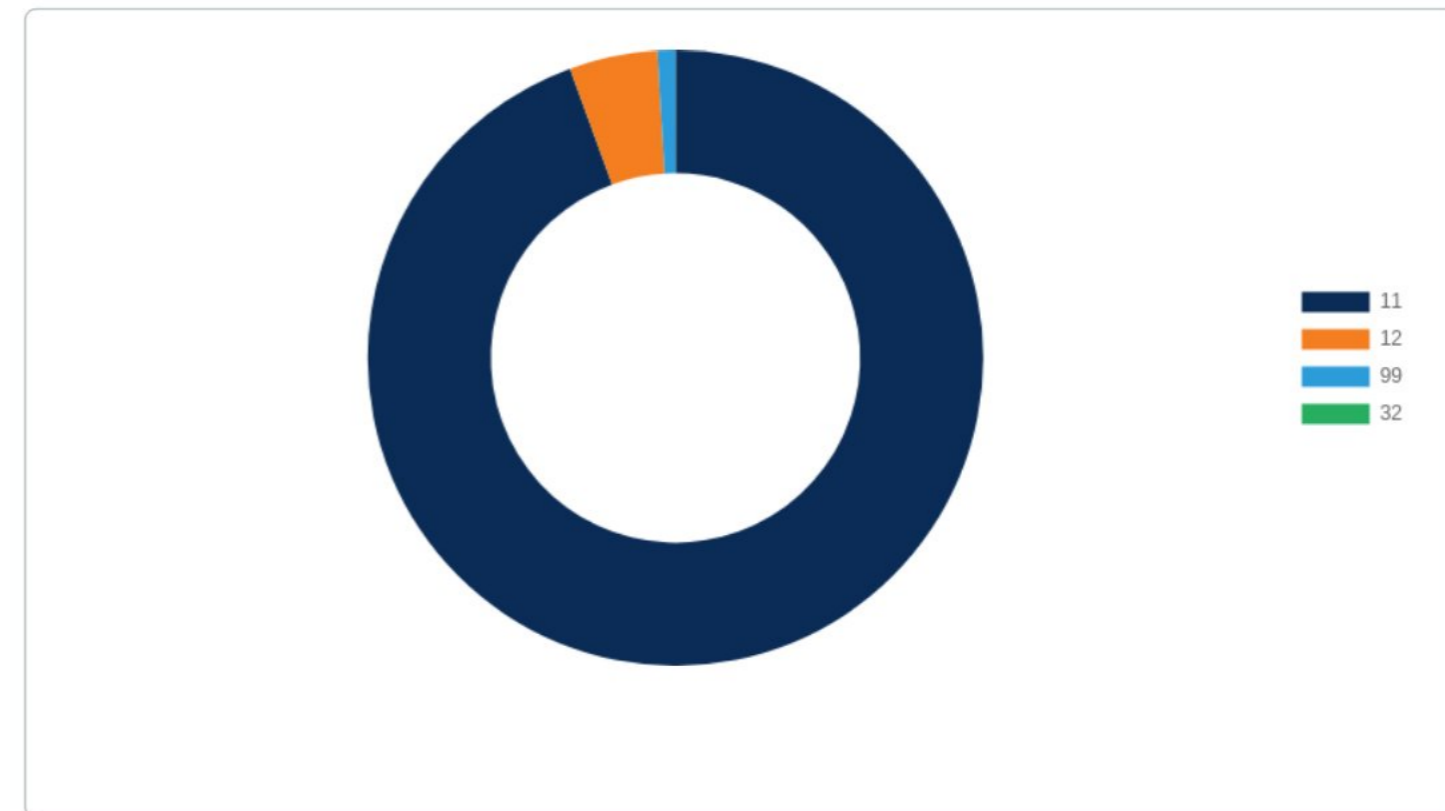

Breakdown of trading value by trading group

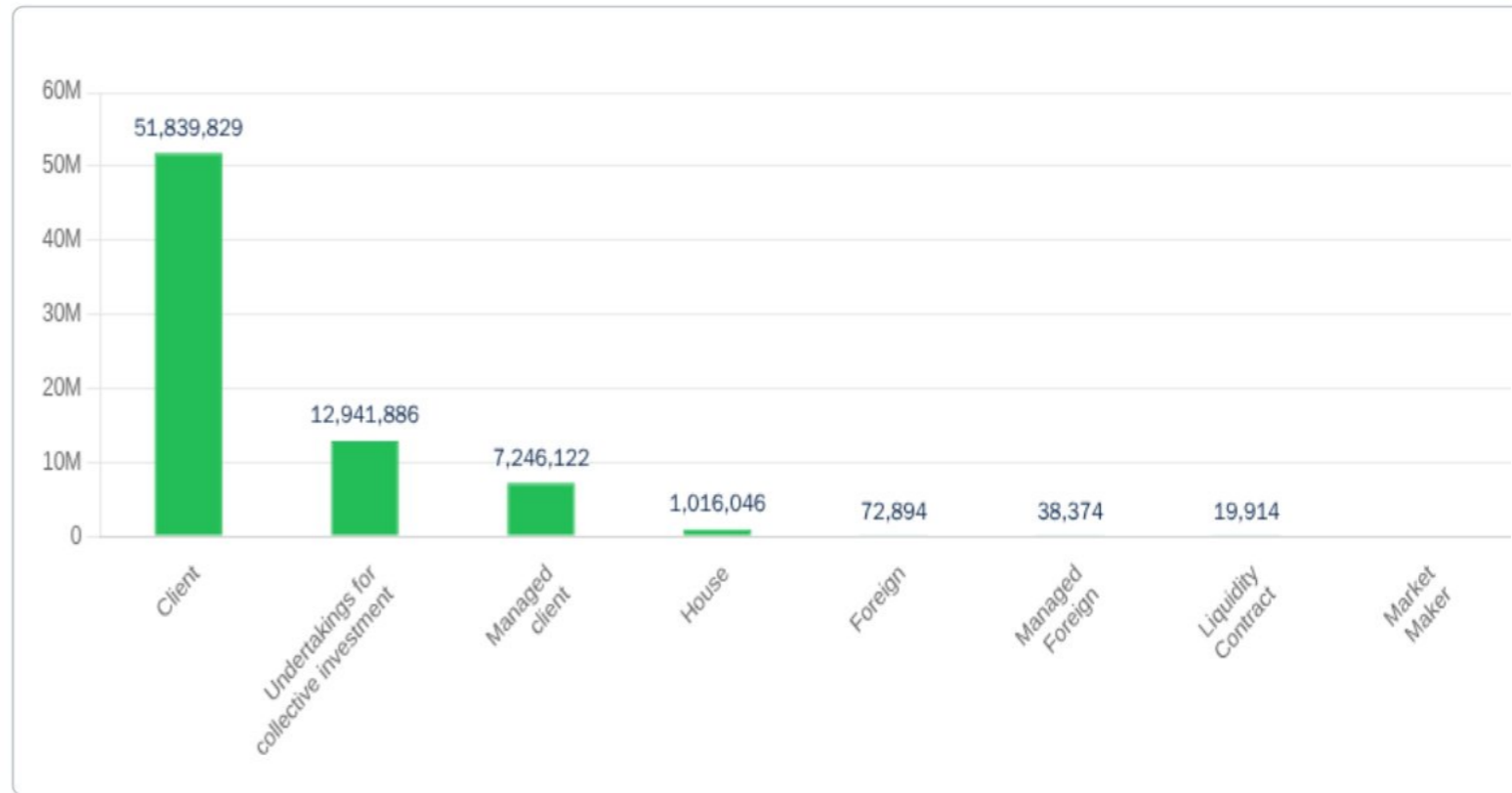

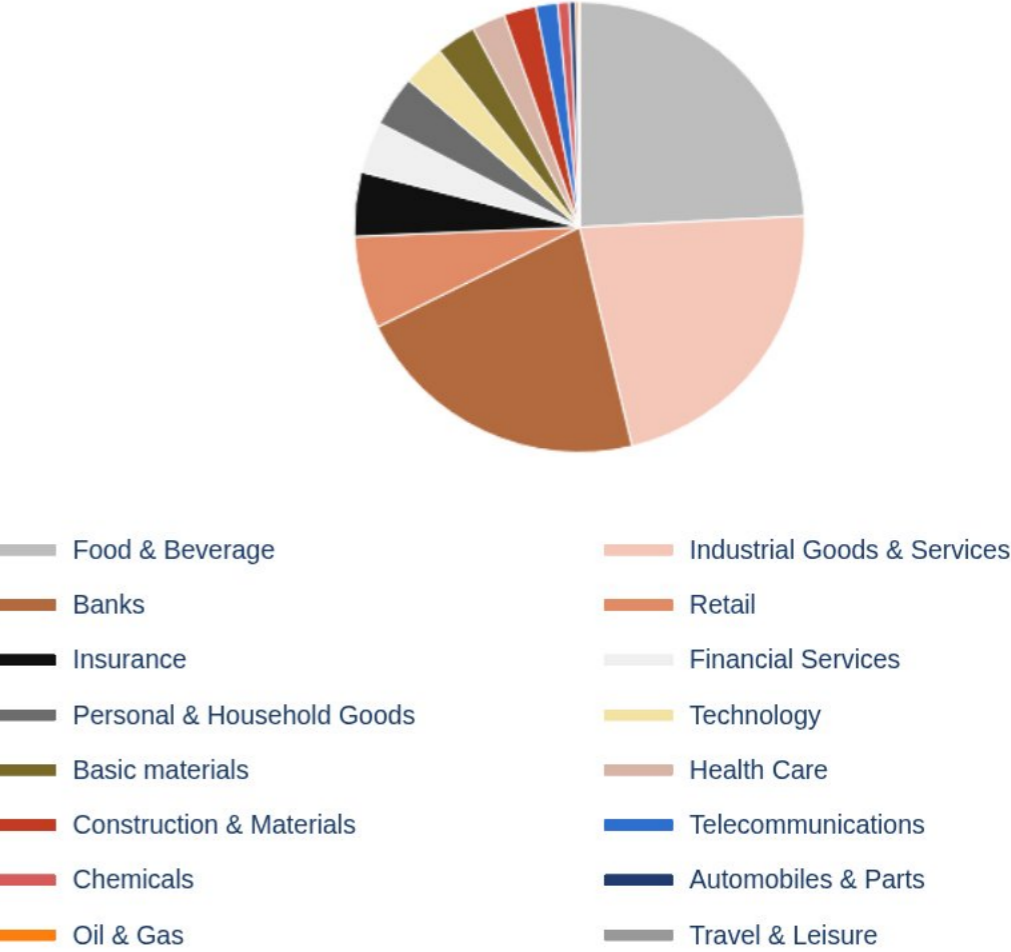

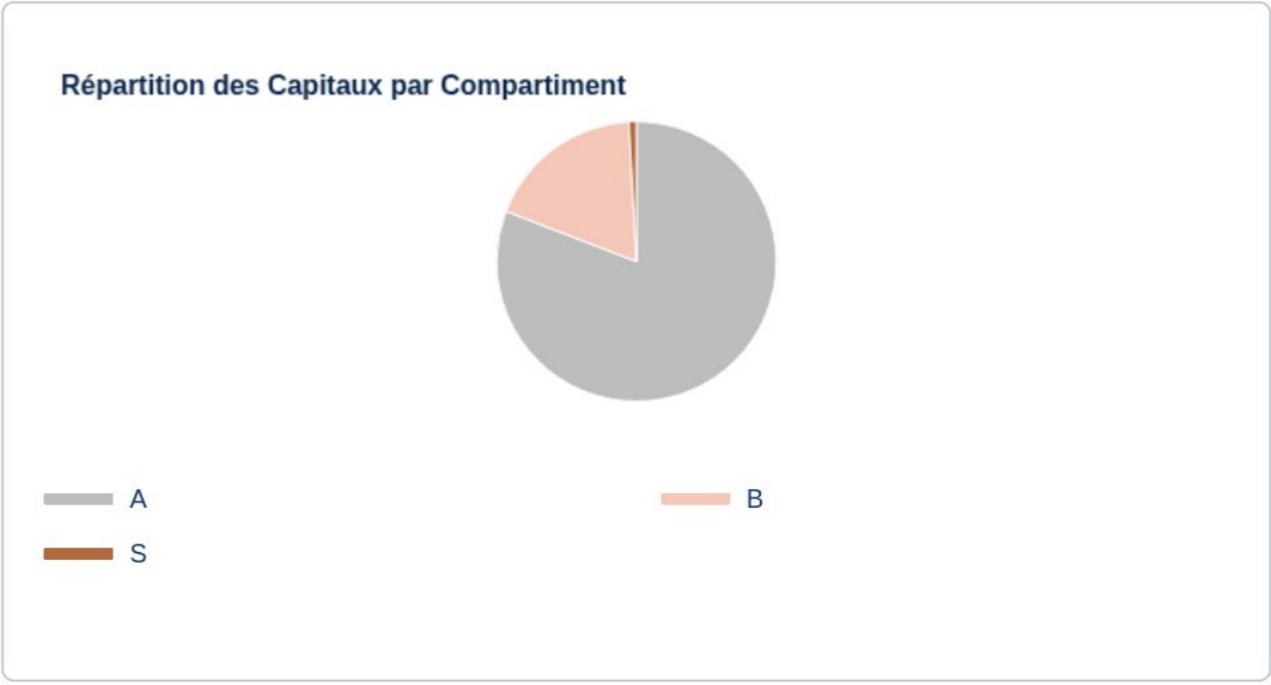

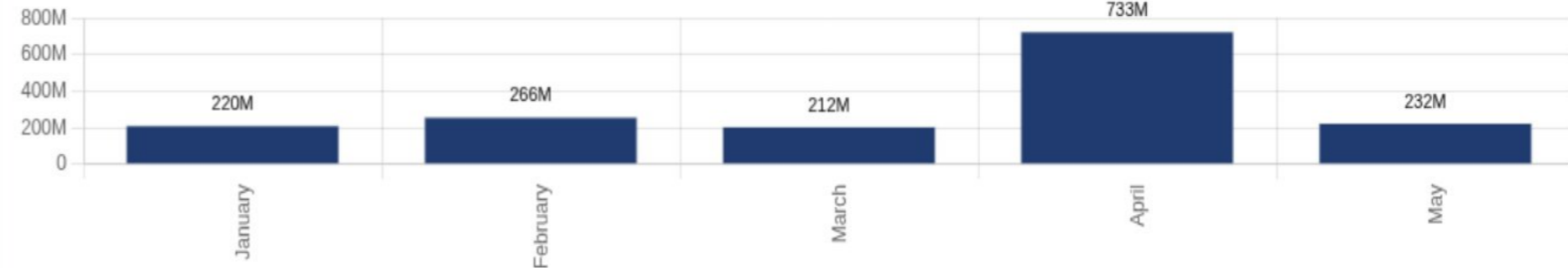

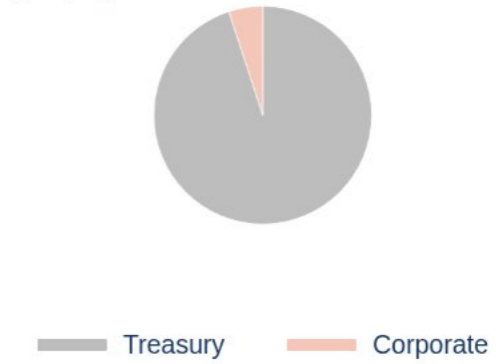
